Committees, the most formal of work groups, are groups of persons appointed or selected to perform a function on behalf of a larger group (the board in this case). In a sense, the larger body entrusts a smaller subset of members to do something for them, usually with a formal written charter.

Task Forces may be created by Committees, subject to approval by the Board. Task forces are smaller groups of people, preferably with experience and expertise in the area,—and resources—brought together to accomplish a specific objective, with the expectation that the group will disband when the objective has been completed. An example would be the Facilities Identification Task Force which would fall under the purview of the Internal Affairs Committee and disband after the board accepts the Task Force's recommendation of a suitable facility. Other facilities related tasks could come up in the future for which the Internal Affairs Committee would then create and appoint another task force.

So in summary, Task Forces should be appointed where the work is of limited duration and/or for a specific purpose. They should be disbanded when the task or project is complete.
